**ANNOUNCEMENT  
REGARDING THE 2026  
FIRST QUARTER REPORT**

This announcement is made pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited and Inside Information Provisions under Part XIVA of the Securities and Futures Ordinance (Cap. 571, Laws of Hong Kong).

The power generation of China Longyuan Power Group Corporation Limited\* (the “Company”), together with its subsidiaries, collectively the “Group”) for March 2026 on a consolidated basis amounted to 6,285,465 MWh, representing a year-on-year decrease of 16.94% as compared with the corresponding period of 2025. During the month, the wind power generation registered a year-on-year decrease of 24.88%, and solar power generation registered a year-on-year increase of 36.81%.

As of 31 March 2026, the cumulative power generation of the Company for 2026 amounted to 19,821,127 MWh, representing a year-on-year decrease of 2.29% as compared with the corresponding period of 2025, of which the wind power generation registered a year-on-year decrease of 7.31% and solar power generation registered a year-on-year increase of 33.30%.

Details of the power generation of the Group for March 2026 are set out as follows:
